Recent Biofuels and Alternative Energy Experience

In addition to working across a spectrum of commodities trading clients (covering Crude, Gasoline, JP Power, Grains, Coffee, Metals, Chemicals) have recently worked with a number of clients to implement biofuels and alternative energy trading solutions:



EDFT were moving into bio-ethanol trading. They had hired an experienced trader, but had no system capability to support physical biofuels trading, lacked required registrations with ISCC, REACH and WebICE (for MOC).

The Qsol team managed board approval for the new business, helping trading team to articulate business plan, agreeing trading limits, configured in-house trading system, and training wider support functions through testing end-to-end scenarios.



CFP Energy were expanding into biodiesel trading. Like EDFT they acquired a trading team, but with no support capabilities. At the same time, they were implementing Molecule as a replacement for in-house Hiro ETRM solution.

Qsol team completed initial implementation of Molecule for exchange-traded business within 3 months, applied extensive configuration so Molecule to value physical biodiesel trades and manage the end-to-end deal lifecycle.

We then migrated the existing trading portfolio, and trained business functions to manage the business within the new system.



Mabanaft were setting up a new desk for trading physical Ammonia as a clean 'last-mile' bunker fuel. They had chosen Molecule ETRM to support basic valuation and risk management.

Our team configured complex physical trading valuation models (based on underlying input products: US Power, Gas, Consumer Indices on different pricing periods), delivered into production use within 3 months.

The team then configured ICE and CME interfaces to support hedging primary commodity market risk, and extended reporting capabilities to interface with cross-desk functions such as Credit, Accounting and Regulatory Reporting.

Other Case Studies

1. Agiblocks CTRM Implementations Across Europe

We've implemented Agiblocks CTRM for five trading firms across Europe in 2023 to 2024, helping them shift from manual workflows to fully integrated systems. Notably, for an agricultural firm, we replaced Excel workflows with Agiblocks and integrated it into their operations, including data migration, system customization, and creating a Power BI reporting tool for better visibility into inventory, contracts, and financials. These projects have enhanced operational efficiency, decision-making, and trade management.

Our experience spans physical commodity trading, financial instruments, and risk management, including futures trading, FX hedging, mark-to-market, and unrealized PnL tracking. We specialize in both position-level and trade-by-trade hedging strategies, ensuring precise exposure management.

We understand various approaches to managing financial risk, whether through brokers, with clearing houses or OTC. This allows us to optimize trade execution, enhance compliance, and offer real-time insights to support strategic decision-making in dynamic markets.

2. Ignite ETRM Implementation for an Oil Trading Company

In this project (one of four Ignite implementations conducted in 2024), we showcased our expertise in energy trading. We led the process from evaluating the best ETRM solution for the client's needs to implementing it. The evaluation required a deep understanding of the client's workflows, challenges, and available solutions. We addressed complex trade flow issues, refined invoicing and contract processes, and integrated real-time risk management to improve operational efficiency and accuracy.

A key part of the project was implementing a delivery management system for large-scale transportation logistics, automating workflows to minimize reliance on error-prone Excel sheets. We also improved pricing and valuation by integrating index-based pricing, ensuring accurate PnL and exposure tracking

.3. ION Endur/Findur Implementation for Base Metals Trader

Quatro Solutions team rescued a failing ION Endur project. Our principal consultant managed a difficult client-vendor relationship, avoiding potential litigation.

Meanwhile the team of 6 implementation consultants, quickly stood up a working trial environment with live business data and implemented a hard-line agile approach – iterating through show-and-tell \Leftrightarrow prioritise-and-fix cycles, ultimately completing the project to a fixed deadline and price.
